

**MINUTES OF A MEETING OF WOLD NEWTON PARISH COUNCIL
HELD IN THE COMMUNITY CENTRE ON MONDAY 1ST JULY 2019**

PRESENT:

Councillor Lockwood (The Chairman), Councillor Dr Meeson, Councillor Botterill, Councillor West, Councillor Barnes and Councillor Cullen. Parishioners Ian & Mandy Tiffany, Colin Goodman & Janice Robinson were also present.

ITEM 1 – Apologies and Declarations of Interest.

Councillor Robinson made his apologies for non-attendance and Councillor Cullen declared a non-pecuniary interest through her membership of Wold Newton Community Centre.

ITEM 2 – Minutes and matters arising from the meeting held on 13th May 2019.

The minutes of the previous meeting had been circulated to Councillors prior to the meeting.

We discussed the state of the road leading to Burton Fleming, again. The Clerk will chase, again.

ITEM 3 – Correspondence.

The Humberside Police Parish/Town updates.

ITEM 4 – Defibrillator update.

The monies from Lissett Wind Farm is still not in the account, we have confirmation from Laura Burley that it has been sent for payment so should be in very soon. The clerk is happy how the 2 CPR training sessions were attended, and we all agreed these should be held yearly.

ITEM 5 – Speeding update.

An email was received from David Hudson on 17th June advising us that Wayne Goodwin has been appointed as the co-ordinator for the Community Speed Watch scheme, he launched and managed the same scheme in Lincolnshire. We all agreed to invite him to a meeting.

ITEM 6 – Footbridge update.

Councillor Barnes chased James Skelton as the bridge is deteriorating rapidly, he said he will be repairing it next week.

ITEM 7 – Use of new available land.

The Woodland Trust have got back to us advising that we cannot ask for additional hedging however we can apply for 420 more saplings in November, in fact we can apply every 6 months.

ITEM 8 – Planning Application Ref: 19/00531/PLF

This application is an update to the previous application 17/00545/PLF, the Councillors agreed there is no further comments from the Parish Council.

ITEM 9 - Railings around green.

We have a quote from James Skelton including removing the old railings, soil, grass seed, skip hire and labour, for £2400. We have also had a quote from Peter Milner for £600 + VAT for labour alone. Councillor West will supply the materials as we are still wanting to keep the railings white. Before getting the ball rolling with this, we will check if it is something we can get the ERYC to do for us.

ITEM 10 – Statement by The Chairman

The Chairman explained how the transport report we had used to object to the Laking Lane style of development was not carried out by the Council as we had thought. The report was in fact funded by Mr & Mrs Tiffany to support their own planning application. The Chairman made a public apology on behalf of the Wold Newton Parish Council. The Clerk also apologised for the report and comments being added to the planning pages and not removed quick enough, though out of her hands as the system to remove is not a quick process.

ITEM 11 - Accounts to pay.

We paid the Community Centre £53.05 for hire of the hall for our meetings.
We paid Will Gray £300 for the green cutting.

ITEM 12 – Any Other Business.

The Chairman thanked Councillor West for the bench he has arranged and had put on the hilltop towards Fordon, so walkers and cyclists can enjoy the view.

The Clerk commented that the additional waste bin we have planned is getting a visit from the refuge department to check they can empty it on their rounds.

Councillor Cullen commented on the long grass that has been missed outside the community centre, the Clerk will contact the council to check why it has been missed.

Councillor Meeson has found out the street lights will not save anything by being turned off during the night as the rate is so cheap as Economy 7. The best way to save anything on the bills would be to turn on an hour later and turn off an hour later. We will get some quotes for this.

The Councillors all agreed and proceeded to co-opt Councillor West back on to the Parish Council as he was out of the country during the elections. The relevant paperwork will be signed as soon as possible.

ITEM 14 - Date of the next meeting.

The next meeting will be held on Monday 9th or 16th September 2019 at 7.30 pm in the Community Centre.
