

**MINUTES OF A MEETING OF WOLD NEWTON PARISH COUNCIL  
HELD IN THE COMMUNITY CENTRE ON MONDAY 13<sup>th</sup> MAY 2019**

**PRESENT:**

Councillor Lockwood (The Chairman), Councillor Dr Meeson, Councillor Botterill, Councillor Robinson, Councillor Barnes and Councillor Cullen. Parishioner Ian Robinson was also present.

**ITEM 1 – Apologies and Declarations of Interest.**

Councillor West made his apologies for non-attendance and Councillor Robinson declared a non-pecuniary interest through his membership of the Wold Newton Parochial Church.

**ITEM 2 – Minutes and matters arising from the meeting held on 8th April 2019.**

The minutes of the previous meeting had been circulated to Councillors prior to the meeting.

The recently repaired road on Back Street, that has already broken away, has not been repaired yet so the clerk will chase.

We haven't heard from the council whether they will empty the new bin, if we organise it. The clerk will chase refuse streets & grounds dept.

**ITEM 3 – Correspondence.**

The Humberside Police Parish/Town updates.

A letter has been received to invite us to the annual town & parish liaison meeting on 23<sup>rd</sup> May. The Clerk and Chairman will attend.

**ITEM 4 – Defibrillator update.**

The monies from Lissett Wind Farm have still not been received so the clerk will chase again.  
The clerk will hold another CPR training session in the school on 5<sup>th</sup> June at 5:45pm.  
The solar light has been fitted and is in fine working order.

**ITEM 5 – Speeding update.**

We are on the list for the Community Speed Watch. We were asked for details as to when and where we want it carrying out, we replied with Bridlington Road/Laking Lane at 8-9am & 5-6pm, the clerk sent these details on 10<sup>th</sup> April. They replied stating they are still waiting for a Speed Watch coordinator. The clerk will chase the police about going into the school to educate the children on the importance of slowing down in built up areas, which they would hopefully feedback to their parents. This was suggested by PC Rob Cocker at our meeting last year.

**ITEM 6 – Footbridge update.**

James Skelton will be repairing the bridge with the materials supplied by Councillor West.

**ITEM 7 – Use of new available land.**

We discussed planting the 420 tree saplings, which have been donated from the Woodland Trust, we are hoping to plant them around the edge of the field, the clerk will contact the trust again to see if we can request additional hedging.

**ITEM 8 – Planning Application Ref: 19/00528/PLF**

This application is for an outbuilding to be changed to a single-story house. We agreed that we do not have any objections but would like to comment that parking be off the street.

**ITEM 9 – Planning Application Ref 19/01220/REM**

This application is for full planning permission for 8 dwellings on Laking Lane. The land was granted outline planning permission on 24<sup>th</sup> May 2017. Looking at the new plans, we all agreed that the 4 houses on the roadside are too linear. The rest of the village has properties built quite sparsely and we feel this will spoil the look of the village. It seems the 4 smaller houses have been crammed together leaving masses of room at the back for the 3 larger houses. A similar development has been built in Foxholes, North Yorkshire with parking around the back of the houses with one entrance/exit which we feel would be a safer and more attractive option. An additional concern is that the road is narrower at this point of the street and constantly has parked cars at the opposite side of the road, if any cars were to be parked on the road at the proposed site it would be hazardous. These Parish Council comments will be added to the planning application form on the website.

**ITEM 10 – Planning Application Ref 19/01089/REG3**

This planning is to add a lean-to canopy to Wold Newton School. We confirmed that as a parish we have no observations.

**ITEM 11 – Railings around green.**

We realise the railings are rotting away so need replacing. Councillor Barnes will ask James Skelton to quote for his labour to replace them, and Councillor West for the materials. We'll get quotes for tanalised wood and also treated wood to paint white.

**ITEM 12 – Accounts to pay.**

The annual audit is due, forms were signed and will be signed off by Shirley Sutton.

**ITEM 13 – Any Other Business.**

The state of Bridlington Road is now a complete state, the clerk will send more emails to transport regarding this. We will ask why was the Thwing road resurfaced when it wasn't as bad and why are we being fobbed off constantly?

Richard Shipley's sheep are still are being unruly, the clerk will send a letter.

Several complaints have been made regarding the scrap cars at 7 Bridlington Road, the clerk will contact the council to visit.

**ITEM 14 - Date of the next meeting.**

The next meeting will be held on Monday 1<sup>st</sup> July 2019 at 7.30 pm in the Community Centre.
