He has suggested ways of doing this and checking for holes within the pond. He has suggested ideas for planting around the pond so that the boarding can be removed and create a different water edge to make the area more attractive. Councillor Ellis has further details and was going to look into the further and may well have another meeting with him.

Fence Repair and Bin – the repairing of the fence is scheduled to be done either the last week in May or the second week in June. No date yet for the bin but Councillor Ellis was going to chase this.

A general clean up of the area including where the faux boat is would be nice and this is something to be looked into or ask individuals to take on tasks. Might be worthwhile asking the Gardening Club if they would be interested in helping.

The area around the bus shelter needs some attention to and cleaning although a Parishioner has done some bits although it is difficult to keep the area free of bird excrement due to them nesting and perching in the trees surrounding the area.
