ITEM 4 - Public Forum - Residents Views and Comments

Sara Youngman presented and read an anonymous letter and petition regarding noise levels and disturbance to the villagers from the Anvil Arms when they host their outdoor disco evenings. The Landlord of the Anvil Arms was in attendance. The letter is wrote to the ERYC and Parish Council. Various discussions occurred between objectors and pub landlord and supporters.

Councillor Ellis responded by thanking them for bringing it to the Parish Councils attention then advising that if the matter could not be resolved amicably and by compromise on both parts then the objectors to the noise should complain to environmental health at ERYC

Parishioner Botterill commented that a vehicle has been parked on Butt Lane form some time and was cause for concern.

Action – Clerk to report and request its removal.

Parishioner Taylor is concerned about the lack of disabled access to the bus provided. Having asked at the bus company herself she wondered if the Parish Council could aid with getting better access. Action – Clerk to approach bus company.

ITEM 5 - Village Pond and Green

Councillor Ellis has been trying to gain further advise and help from Hugh Roberts of Howden Parish Council but to date has had no response, he will endeavour to speak with him again and despite the low levels of water in the pond the leak had yet to be identified. Parishioner Gray questioned that damage could possibly have been done to the pond on a previous dredging exercise and therefore there may be numerous leaking points.

A village clean up of the area is still to be arranged although it is getting a little late in the season now with are the following areas been proposed for tidying.

The bridge across the pond could do with attention and this could possibly be done through a grant scheme however the date for the Lisset Wind Farm Grant has now passed so this is something we could potentially look into next year.

A Facebook plea was proposed and will be done in due course to ask for help in these areas.

No further grants available at present. Parishioner Bridges asked if the Community Energy Fund could be explored further.

Action – Clerk to look into Community Energy Fund.

ITEM 7 - Speeding

The Clerk has spoken with the Humberside Community Speed watch and they have not ruled out joining with another group although no further contact has been made from Burton Flemming on either sides.

Action – Clerk to keep in touch with all parties.

ITEM 8 – Gas Drilling – Foxholes (discussed in Public Forum)

Councillor Ellis reported that at this stage the formal planning application has yet to be submitted. This ultimately means that the Parish Council can only gain peoples opinions on the plan. Generally the opinion is that the community is against the plans and has various different concerns if it were to get the go ahead.

Foxholes and Butterwick Parish Council will be notified if and when a application is submitted as it is in their Parish and they will then make it public as they have been very active in gaining opinions and organising meetings in readiness for an application.

A meeting has been arranged for 9am on Saturday 19th July 2025 at Foxholes Community Centre where Kevin Hollinrake, (Foxholes MP) and Cllr Janet Sanderson from North Yorkshire Council will be in attendance to give their views and guidance. A leaflet drop was to be arranged for the Parish with details of the event.

Updates and any information received will be re-laid to the Community as soon as it is available and any offers of help will be gratefully received.

ITEM 9 – Councillor Vacancy

Parishioner Ryan Todd attended the meeting and was asked if he was still willing and able to fill the current vacancy.
