ITEM 5 – Defibrillator Training

Butterwick and Foxholes Parish Council would like to share some training for the Defibrillator with Wold Newton. The Clerk has received a quote of £180 plus VAT from ASB First Aid. Butterwick and Foxholes are provisionally happy with this quote as others received had been in excess of £1,000. The training would be for approximately 6 people from each Parish Council.

Action: Committee happy with proposals. Clerk to report back to Butterwick and Foxholes Parish Council. Two Councillors would like to attend and others from the village could then be asked to fill any remaining places.

ITEM 6 – Grants

Several grants are currently favourable and all have been distributed within the Committee for their thoughts. Our application for the Do It For East Yorkshire (DIFEY) was unsuccessful last year however this would not stop the Parish from being able to reapply this year. The Lissett Wind Farm Grant seems possibly more attainable although the deadline for applications is tight. It was decided to put an application in for the Wind Farm Grant for the project currently undergoing to improve the Pit Field and Pin Fold areas. The grant would primarily be to fund some picnic tables for Pit Field to make this more accessible and usable for residents and for them to be able to enjoy the improvements already implemented.

Action – Clerk to apply for Lissett Wind Farm Grant – Councillor Ellis to supply information for grant regarding works already completed.

ITEM 7 – Area of Outstanding Beauty

Nothing really to report with regard to this. The area proposed looks set and Wold Newton is not included within that area.

ITEM 8 – Speeding

Angela Barnes has forwarded an e-mail containing information from PC Wayne Goodwin on the possibility of us obtaining an AutoSpeedWatch Camera with could possibly be obtained with subsidy. With speeding still been a problem within the village and other deterrents being extremely costly the Committee think this may be a viable option.
